Investment & Fees

Your contributions will be added to the existing Fund account within the same investment option you have chosen. The Fund does not charge any entry fees – your personal contributions are fully allocated to your account.

Preservation

All superannuation contributions are subject to preservation. You generally cannot withdraw your contributions until you retire after reaching the qualifying age.

Tax File Number (TFN)

Under the Superannuation Industry (Supervision) Act 1993, your superannuation fund is authorised to collect your TFN, which will only be used for lawful purposes.

These purposes may change in the future as a result of legislative change. The Trustee may disclose your TFN to another superannuation provider, where your benefits are being transferred. The Trustee will not pass on your TFN if you instruct the Trustee in writing. You are not required to provide your TFN. If we do not receive your TFN from you or your Employer then:

- Any concessional contributions (such as Employer and Salary Sacrifice) will be taxed at the top marginal rate of 47% rather than the usual 15% if we have not received your TFN.
- Any non-concessional contributions (such as your voluntary after tax contributions) will be returned to you within 30 days. We will try to contact you during that time to obtain your TFN. Your contribution will be allocated to your account from the date your TFN is received by us.
